WHAT SUNLIFE MULTIVITAMIN & MINERALS EFFERVESCENT TABLETS CONTAIN:

Each 4,5g Tablet contains *Active Ingredients*:

Calcium (as Calcium carbonate)	80 mg
Magnesium (as Magnesium carbonate)	30 mg
Potassium (as Potassium carbonate)	40 mg
Vitamin C (Ascorbic acid)	60 mg
Vitamin B3 (Niacin)	18 mg
Vitamin B3 (Niacin)	18 mg
Vitamin B5 (Calcium-D-Pantothenate)	6,0 mg
Vitamin B6 (Pyridoxine HCL)	2,0 mg
Vitamin B2 (Riboflavin 5'-phosphate, sodium)	1,6 mg

WHAT IS SUNLIFE MULTIVITAMIN & MINERALS EFFERVESCENT USED FOR?

This medicine contains a complete oral Multivitamin and Minerals supplement to help aid normal health and function.

WHAT YOU NEED TO KNOW BEFORE YOU TAKE SUNLIFE MULTIVITAMIN & MINERALS EFFERVESCENT.

Warnings and precautions. Do not take if:

You are allergic to any of the ingredients listed

Always tell your Healthcare Professional if you are taking any other medicine or if you have any illness or condition before taking Sunlife Multivitamin & Minerals Effervescent or:

- If you have liver problems
- If you have kidney problems, including producing little or no urine
- If you have severe and persistent diarrhea and sickness
- If you are unable to drink fluids, or are unable to keep fluids down
- If you have diabetes
- If you have heart disease

Pregnancy and breastfeeding

If you are pregnant or breastfeeding, think you may be pregnant, or are planning to have a baby, ask your doctor, pharmacist or healthcare professional for advice before taking this medicine.

Driving and using machinery

Sunlife Multivitamin & Minerals Effervescent does not affect your ability to drive or the ability to use or operate machinery.

Taking other medicines with Sunlife Multivitamin & Minerals Effervescent

If you are taking other medicines on a regular basis, including complementary or traditional medicines, the use of Sunlife Multivitamin & Minerals Effervescent with these medicines may cause undesirable interactions. Please consult with your doctor, pharmacist or your healthcare professional for advice.

HOW TO TAKE SUNLIFE MULTIVITAMIN & MINERALS EFFERVESCENT

Always take Sunlife Multivitamin & Minerals Effervescent exactly as described in this leaflet, or as your healthcare professional has instructed you. You should check with your healthcare professional if you are not sure. Do not share your medicines with any other person.

Adults Only: Dissolve one (1) tablet in 250ml of water daily.

If you take more Sunlife Multivitamin & Minerals Effervescent than you should

In the event of overdosage, consult your doctor or pharmacist immediately. If neither is available contact the nearest hospital or poison control center.

If you forget to take a dose of Sunlife Multivitamin & Minerals Effervescent

Do not take a double dose to make up for forgotten doses but continue to take the usual dose at the usual time.

POSSIBLE SIDE EFFECTS

Sunlife Multivitamin & Minerals Effervescent can have side effects.

No side effects have been reported when taking the recommended or prescribed dose.

Not all side effects reported for Sunlife Multivitamin & Minerals Effervescent are included in this leaflet.

Should your general health worsen while taking this medicine, please consult your doctor, pharmacist, or healthcare professional for advice.

If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

STORING AND DISPOSING OF SUNLIFE MULTIVITAMIN & MINERALS EFFERVESCENT

Keep all medicines out of reach and out of sight of children. Store in a cool dry place at or below 25°C (room temperature). Store in the original container.

Keep the container tightly closed. Do not store in a bathroom.

Do not use after the expiry date stated on the label/carton and base of the tube.

Return all unused medicine to your pharmacist.

Do not dispose of unused medicine in drains or sewerage systems (e.g. toilets).
